

**RESOLUTION ADOPTING DEVIL'S RIVER STATE TRAIL MASTER PLAN**

TO THE MANITOWOC COUNTY BOARD OF SUPERVISORS:

1           WHEREAS, the Wisconsin Department of Natural Resources, the Wisconsin Department  
2 of Transportation, and the Manitowoc County Planning and Park Commission have determined  
3 that development of the Devil's River State Trail has a high priority; and  
4

5           WHEREAS, Manitowoc County has agreed to oversee the development, operation, and  
6 maintenance of the Devil's River State Trail through an easement with the Department of Natural  
7 Resources; and  
8

9           WHEREAS, the Devil's River State Trail consists of approximately 14 miles of shared use  
10 rail-trail located in Brown and Manitowoc Counties and an undeveloped segment located in  
11 Southeast Manitowoc County; and  
12

13           WHEREAS, Manitowoc County contracted with Bay Lake Regional Planning  
14 Commission for assistance in the development and facilitation of the master plan for the Devil's  
15 River State Trail; and  
16

17           WHEREAS, the Devil's River State Trail Master Plan is intended to serve as a guide for  
18 Manitowoc County for the development, use, operation, and maintenance of the Devil's River  
19 State Trail; and  
20

21           WHEREAS, Bay Lake Regional Planning Commission held an open house on May 20,  
22 2019 to solicit feedback on trail use and rank future funding priorities; and  
23

24           WHEREAS, the Planning and Park Commission held a public hearing on September 23,  
25 2019 to review the draft plan and seek public comment; and

27           WHEREAS, the Planning and Park Commission, after a careful consideration of testimony  
28 and an examination of the Devil's River State Trail Master Plan, recommends that the Manitowoc  
29 County Board approve the Devil's River State Trail Master Plan;

31           NOW, THEREFORE, BE IT RESOLVED that the Manitowoc County Board of  
32 Supervisors hereby adopts the Devil's River State Trail Master Plan in its entirety as presented to  
33 the Manitowoc County Board on this date.
