CIVIL PROCESS FEE SCHEDULE

Effective: January 1, 2010

Process Fee: Service: \$40 a person (includes 1 attempt)

\$30 for each *additional* attempt
(A maximum of 2 additional attempts can be charged.)

In the event that a process server is able to serve more than one person at the same address, on the same date, at the same time, the fee for the second and each additional service will be \$40.

Posting: \$75 for posting
\$75 for sale

Writs: \$75 (includes 1 hour of standby time)
Additional standby time will be charged at \$40 an hour.


